

### COVID-19 IMPACTS: FALL 2021 AND SPRING 2022 ENROLLMENT

DECEMBER 11, 2021 UPDATE

## COURSE MODALITY COMPARISON

The change in distribution of course modalities from Fall 2021 to Spring 2022 is presented in Table 1 below. As noted, dual enrollment CCAP courses that take place on high school campuses are NOT included in these or subsequent course modality counts.

## ENROLLMENT BY COURSE MODALITY

The percentage of enrollments in the respective course modalities (On Campus only, Hybrid with both on campus and online required meetings, and Online only) are presented in Table 2 below. The percentages for Spring 2022 will continue to change as enrollment continues through the start of the Spring 2022 semester.

## STUDENT HEADCOUNT BY COURSE MODALITY

The number of students (i.e., student headcount) enrolled in each course modality is presented in Table 3 below. The majority of students are enrolled in on-campus courses and they align with the distribution of sections and enrollments presented above. These numbers will continue to change through the start of the Spring semester.

#### FALL ENROLLMENT TREND AND COVID-19 IMPACT

Over the past five fall semesters, the District has seen a decline in Fall enrollment, a trend that has continued and has been exacerbated by the COVID-19 pandemic, as seen in Fall 2020 and Fall 2021 in Table 6 below.

These declines have not occurred equally across student populations, with Low Income students and Latinx students showing the largest declines. The impact of these declines has further impacted the planned expansion of the Promise Scholars Program (PSP), as shown in Table 7 below.

#### PROMISE SCHOLARS PROGRAM

The COVID-19 pandemic continues to negatively impact overall District enrollment, which has impacted the planned expansion of the Promise Scholars Program (PSP). For the first time in 5 years, the number of Full Time First-Time students declined overall from N = 2,013 in Fall 2019 to N = 1,758 in Fall 2020 and N = 1,402 in Fall 2021.
