The San Mateo County Community College District (Cañada College, College of San Mateo and Skyline College) signed the Certification and Agreement on April 30, 2020. The three colleges will allot 75% of the CARES Act funds received for emergency grants to students. Of these funds 67% were disbursed in the Spring 2020 semester and 33% were disbursed in the Fall 2020 semester. As needed, additional funds were reallocated from institutional funds to support emergency grants.

Students ineligible to receive funds:

- Enrolled in online-only degree programs (SMCCCD's colleges do not have degree programs that are fully online)
- Dropped all courses prior to September 9, 2020

Grant Amount:

- \$650 Full-Time (12+ units)
- \$500 Part-Time (6-11.5 units)

Note: For students who do not claim their full or partial award, funds will be canceled and re-awarded to another student. However, this is done only after multiple attempts at communicating with the student. One communication includes a 10-day final notice that funds will be canceled if they don't claim their award refund. All students received a notification when they were awarded HEERF funds. The notification

explained what the money could be used for, refund options, and which students need to submit documentation.

Students that need to submit additional documentation include FAFSA eligible students without a FAFSA with the college (s) and undocumented students without Selective Service verification. These students received a separate notification instructing them to complete CARES Grant Supplemental Form to determine eligibility.

The Higher Education Emergency Relief Fund II (HEERF II) is authorized by the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA), Public Law 116-260, signed into law on Dec. 27, 2020. In total, the CRRSAA authorizes \$81.88 billion in support for education, in addition to the \$30.75 billion expeditiously provided last spring through the Coronavirus Aid, Recovery, and Economic Security (CARES) Act, Public Law 116-136.

The San Mateo County Community College District (Cañada College, College of San Mateo and Skyline College) received \$13,361,763 and will allot 54% of the CRRSAA HEERF II funds received for emergency grants to students. Of these funds, between 82-85% will be disbursed in the Spring 2021 semester and 12-15% will be disbursed in the Fall 2021 semester. As needed, additional funds may be reallocated from institutional funds to support emergency grants.

The Higher Education Emergency Relief Fund III (HEERF III) is authorized by the American Rescue Plan (ARP), Public Law 117-2, signed into law on March 11, 2021, providing \$39.6 billion in support to institutions of higher education to serve students and ensure learning continues during the COVID-19 pandemic.

ARP funds are in addition to funds authorized by the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA), Public Law 116-260 and the Coronavirus Aid, Recovery, and Economic Security (CARES) Act, Public Law 116-136. Emergency funds available to institutions and their students under all emergency funds total \$76.2 billion

The San Mateo County Community College District (Cañada College, College of San Mateo and Skyline College) received \$23,248,192 and will allot 50% of the CRRSAA HEERF III funds received for emergency grants to students. Of these funds, 10% will be disbursed in the Summer 2021, and 50% in Fall 2021. As needed, additional funds may be reallocated for the Spring 2022 semester.
