

The AIFS Internship in Dublin program fee of \$8,490 includes the following:

Internship Support

- Guaranteed internship placement upon acceptance into program.
- Access to the renowned CliftonStrengthsFinder assessment.
- One-on-one professional development with the AIFS Abroad Program Advisor including resume review and interview practice
- Video conference or phone interview with the internship organization prior to departure
- Support by local AIFS Internship Coordinator for the duration of the program.
- Orientation program in Dublin consists of a meeting with AIFS staff on information such as safety and security, cultural activities, workshops on cultural differences, and a local area walking tour.

Accommodation:

- Single rooms with private, en-suite bathroom within a student residence with shared kitchen and living/dining rooms, laundry access, linens, and Wi-Fi. No meals are provided. Located close to public transportation, students may have a 30-60-minute travel time to their work placement and the city center.

Cultural Activities and Excursions. Typical activities, tours and visits and may include:

- Guided tour of Dublin
- Lunch and live music at a pub
- Day trip to the Cliffs of Moher
- Weekend to Belfast including day trip to Giant's Causeway

Also Included:

- Services of dedicated AIFS staff for information, advising, and 24-hour emergency contact service
- Medical insurance policy
- Carbon offsetting for all participants' flights to and from their program location by the purchasing of carbon credits in vetted global projects.

Program does not include the following:

- Round-trip airfare and in-country transfers.
- Passport and visa fees if applicable.
- SMCCCD tuition or administrative fees or textbooks
- Meals other than those listed.
- Personal expenses.
- Anything else not specified.

Refund policy and important dates to remember should you need to cancel your participation:

1. All deposits are non-refundable as they fund core services related to the program. Some of these services include, but are not necessarily limited to admissions counseling, program advising, professional document revision, work put in by the placement team, interview preparation, and access to professional and program resources through the online portal.
2. Should a participant choose to withdraw from their program, eligibility for a refund and the amount of the eligible refund will be determined based on the format outlined below.
3. Using the postmark, email or fax date of a participant's withdrawal letter as the official withdrawal date (or next business day if this is a weekend), the following applies:

More than 61 days before program start (on or before April 6, 2026)	100% refund less \$500 deposit.
Between 31- and 60-days program start (withdrawing on April 7, 2026 to May 6, 2026)	50% refund less \$500 deposit.
Within 30 days of program start (withdrawing on or after May 7, 2026)	Recoverable costs only less \$500 deposit.

Protecting your investment:

Participants may purchase additional trip cancellation or interruption insurance which allows them to protect their study abroad program. This policy includes options to cancel for any reason (CFAR) and interrupt for any reason (IFAR). Details of the Worldwide Trip Protector Plans with Travel Insured International (TII) is underwritten by the United States Fire Insurance Company, rated A (Excellent) by A.M. Information on these options is available on the Travel Insured International website – www.travelinsured.com - or by phone at 855-611-0918. **The policy is time sensitive and must be purchased within 21 days after the deposit is paid.**
